- 1 Counsel appearing on behalf of the State of Gujarat shall take instructions on whether the report of the Enquiry Commission headed by Justice D A Mehta has been tabled before the Legislative Assembly and, if not, whether the State Government proposes to do so.
- 2 The State of Gujarat shall file an affidavit setting out the updated position on compliance.
