UPON hearing the counsel the Court made the following  
O R D E R

There are broadly three issues/subjects arising out of this case.

The first is about the role played by the Advocates who appeared for the petitioner. In that context, we will have to hear the application made by the victim of the offence-respondent No.2. This issue is case specific.

The second issue is of the norms of conduct of Advocates-on-Record. Dr. S. Muralidhar, Senior Advocate, is assisting us on this aspect along with Supreme Court Advocates-on-Record (SCAORA) and Supreme Court Bar Association (SCBA). There are applications for intervention made on this aspect. The intervenors are free to submit their suggestions to Dr. Muralidhar appointed as Amicus in this case. If Amicus is satisfied, he will give a supplementary note on what is suggested to him. At this stage, we deem it proper not to hear the intervenors as both the Bar Associations are represented before us.

The third issue is about the submission made by learned Solicitor General of India regarding revisiting the law and the procedure laid down by this Court regarding designation of Advocates as

Senior Advocates under Section 16 of the Advocates Act, 1961. On that issue, there is an intervention application filed by the petitioner in the original petition in which guidelines have been issued by this Court. This is the third issue which we have to consider.

For considering the first two issues, list the matter on 19.12.2024 at 02:30 p.m. Time permitting, we will take first issue as well.

We allow applicant in Crl. M.P. No.277655 of 2024 to appear and assist us in-person. She will be assisted by Mr. Rohit Kumar, learned Advocate-on-Record.

An affidavit dated 30.11.2024 filed by Mr. Rishi Malhotra, learned senior counsel, is taken on record.

We permit learned Amicus to file additional note.
