O R D E R

Civil Appeals arising out of SLP (Civil) Nos. 7868-7869 of 2025

1. Leave granted.
2. Heard learned senior counsel/counsel for the parties.
3. Since the impugned judgment(s) of the High Court dated 04.02.2025 and 27.02.2025 have been passed adversely impacting the rights of the appellant without affording him reasonable opportunity of being heard, the same is set aside on this ground alone. The matters are remitted to the High Court for fresh adjudication, after hearing the parties.
4. Owing to the urgency involved, the Hon'ble the Chief Justice of the High Court is requested to post the matters for hearing on 02.06.2025 in the urgent list. Since the parties are present before us, the High Court will not be required to issue any notice. We

direct the parties to appear before the High Court on the date fixed. We further request the High Court to make an endeavour to decide the Writ Petition(s) on merits at the earliest and issue appropriate directions, as may be required in the given situation.

4. The appeals are disposed of on the above terms.

5. All the intervenors are permitted to assist the High Court.

6. Pending application(s), if any, including application(s) for intervention stand disposed of.

Civil Appeal arising out of SLP (Civil) No. 10323 of 2025

1. Leave granted.

2. The instant appeal is directed against an order passed by the High Court issuing notice in a Writ Petition without any interim direction. We are informed by the learned senior counsel/counsel for the parties that the Writ Petition is now listed on 11.07.2025.

3. Having regard to the urgency involved, the next date of hearing in the Writ Petition No.9591/2025 (*Sandeep Kumar & Ors. v. Bar Council of Punjab and Haryana & Ors.*) is ordered to be preponed and the Registry of the High Court is directed to list the same on 02.06.2025 before a Division Bench in the urgent list. Since parties are present before us, the High Court will not be required to issue any fresh notice. The pleadings, if any, shall be completed by the parties on or before 03.06.2025. The High Court shall take up the matter immediately for final disposal.

4. Meanwhile, the orders passed by the Bar Council debarring or suspending the member shall be kept in abeyance.

5. The appeal is disposed of on the above terms.

6. The High Court will ignore all those orders passed by the

State Bar Council for the purpose of deciding the matter on merits.

7. Pending application(s), if any, shall stand disposed of.
