UPON hearing the counsel the Court made the following

O R D E R

We have heard learned counsel for the parties at length.

2. In view of non-compliance of our last order dated 09.10.2025, as the Chairman of the Group had not filed a personally affirmed affidavit, which was instead filed by the Group Vice-Chancellor of

Amity Universities and we were informed that all the Universities are run by the Ritnand Balved Education Foundation of which Dr. Atul Chauhan was the President, on a query whether he would be in a position to come to the Court, he agreed to do so and is present before the Court.

3. After deliberating on the issue at length, the Court is not satisfied with either what has been brought on record or the conduct of the respondents. What is worse is that a mockery has been made of the Court's sentiments by producing a cheque of Rs.1,00,000/- (Rupees One Lakh), which has been offered before this Court as compensation. However, we refrain from saying much on the issue, for the present.

4. Let the matter be listed on 18.11.2025, retaining its position.

5. In the meantime, it shall be open for the concerned persons to file any further affidavit which they may deem appropriate.

6. On the next date of listing, Dr. Atul Chauhan, President, Ritnand Balved Education Foundation as also, the Vice-Chancellor of the concerned University shall be present before the Court.

7. We expect that by the next date, the responsibility would be fixed on the persons who may be responsible for the situation in which the University finds itself today.
