UPON hearing the counsel the Court made the following

O R D E R

1. We are informed that the elections for the Supreme Court Bar Association have taken place. The names of the candidates who are elected for the posts of office bearers and Senior Executive Members have been declared by the Election Committee. The counting of votes for the Junior Executive Members is going on. The same is likely to be completed today.

2. Meanwhile, some suggestions have come with respect to the irregularities noticed during the process of election, which need to be rectified by the Registry of the Supreme Court. Let such suggestions be given to the OSD (Registrar) (Judicial Administration-I). Similarly, other suggestions regarding reforms by Members of the Bar may also be filed, preferably before the next date of hearing.

3. During the course of hearing, an issue with regard to "reservation" for women candidates for the post of Senior Executive Members has been raised with reference to the correct understanding of our order dated 02.05.2024 and 06.05.2025. We are informed that out of 6 candidates declared elected, 3 are women candidates. That being so, it is clarified that the object of minimum representation to be given to the women candidates among the Senior Executive Members have been successfully achieved. No further reservation is, thus, required. In other words, the intent of the abovementioned orders was to ensure that a minimum of the stipulated number of women get elected within the executive members of the Association, not to reserve a sub-set of the total posts for women candidates.

4. The Election Committee is directed to preserve the CCTV videos/recordings, which shall be kept in the custody of Mr. Vijay Hansaria, Senior Advocate/Chairman of the Election Committee till further orders.

5. Post the matters on 28.07.2025.
