UPON hearing the counsel the Court made the following
O R D E R

1. Let these petitions be listed for final hearing on 18.11.2025.
2. In the meanwhile, the consultation process as indicated by the learned Attorney General for India can be completed.
3. We also consider it appropriate to have the views of the National Council constituted under Section 3 of the Clinical Establishments (Registration and Regulation) Act, 2010. It is necessary that the National Council is represented before us. A copy of the Writ Petitions may be sent to the Council by the registry with specific instructions that the Council shall represent itself before the Court on the next date of hearing.
4. Pending disposal of the Writ Petitions, we clarify that the Clinical Establishments (Central Government) Rules, 2012 that have been notified, have not been stayed by this Court. As of today they partake the character of applicable law.
5. Learned Solicitor General represents applicant in IA No. 5756 of 2025 (application for intervention). The said application is allowed and General Insurance Council is made a party-respondent to the present proceedings. A copy of writ petitions be provided to the newly impleaded party. Casue title be amended accordingly.
