UPON hearing the counsel, the Court made the following
O R D E R

Leave granted.

Applications for suspension of sentence filed by the
appellants, Feroz Sidhique and Abhay Goel, in the appeals arising

out of SLP (Cr1.) Nos.10272/2024 and 6412/2024 are allowed.

They shall be released on bail during the pendency of the appeals on terms and conditions to be fixed by the trial Court.

Application for suspension of sentence filed by the appellant, Yahya Dhebar, in the appeal arising out of SLP (Cr1.) No.6473/2024 is rejected.

However, we clarify that Yahya Dhebar, the appellant in the appeal arising out of SLP (Cr1.) No.6473/2024, may file a fresh application for suspension of sentence in case of change in circumstances or if the appeals are not taken up for hearing within reasonable time.

Re-list the other applications for suspension of sentence filed by the appellants in the other cases in the week commencing 09.12.2024.

These matters will be listed during the said week, notwithstanding the fact that on leave being granted, they cease to be non-miscellaneous cases.
