O R D E R

Having regard to the fact that expeditious disposal of the cases is required and there are multiple writ petitions pending on similar or identical issues relating to the Common Law Entrance Test (for Undergraduate courses and some for Postgraduate courses) in different High Courts, namely, the High Courts of Delhi, Karnataka, Jharkhand, Rajasthan, Bombay, Madhya Pradesh, Punjab & Haryana and Calcutta, we transfer all such pending cases, the details of which have been provided in Annexure-A attached to this order, to the Division Bench of the High Court of Delhi, which is dealing with L.P.A. No. 1251/2024, titled "*Consortium of National Law Universities v. Aditya Singh (Minor)*" and 1250/2024, titled "*Aditya Singh (Minor) v. Consortium of National Law Universities*".

The records of all the cases in question shall be transferred to the High Court of Delhi expeditiously by Special Messenger/Special Courier within a period of seven days from the date a copy of this order is received in the Registries of the respective High Courts.

We are also inclined to pass an omnibus order that in case a similar or identical issue is raised before any High Court in any other matter, the petitioner, Consortium of National Law Universities, will be entitled to file/place a copy of this order before the said High Court for transfer of the case involving the said issue(s) to the High Court of Delhi.

All the aforesaid transferred cases shall be listed for hearing before the High Court of Delhi on 03.03.2025.

The transfer petitions are disposed of in the above terms.
