ORDER

Nitin Jamdar, C.J.

In *Public Interest Foundation v. Union of India*¹, the Hon'ble Supreme Court has issued certain directions in respect of speedy conclusion of trials in relation to the Members of Parliament (MP) and Members of Legislative Assembly (MLA). The Hon'ble Supreme Court called upon the High Courts to establish Special Courts in every district for the cases relating to MP/MLAs, and issued certain practice directions, including that of cases under stay and for witness protection. It was further directed that each High Court has to register a *suo motu* case, monitor the progress of cases pending in the State, and ensure compliance of the directions of the Hon'ble Supreme Court. Pursuant to the said direction, the present *suo motu* proceedings have been initiated by order dated 16 November 2021. Thereafter, directions were issued to the Respondents to furnish consolidated statement in respect of withdrawal of criminal cases. The Registry (District Judiciary) was also directed to submit the details of the cases pending.

2. By order dated 18 November 2024, we had requested Mr. P.B. Krishnan, the learned Senior Advocate, to act as an *Amicus Curiae*.

3. Since the issue is to be monitored periodically, for the purpose of present hearing, we propose to deal with two aspects. Firstly, the cases which are pending in this Court wherein stay has been granted because of which proceedings have not been taken forward. Secondly, the cases which are pending at the stage of framing charges or statement of charges.

4. With the assistance of the learned *Amicus Curiae* and the learned Director General of Prosecution, we have gone through the data placed on record by the Registry.

Notably, large number of cases are pending at Thiruvananthapuram district, where the cases are 34 as regards the sitting MP/MLAs, 21 as regards the former MP/MLAs, and 2 as regards both sitting and former MP/MLAs. The position in Kollam is, 20 cases are pending as regards the sitting MP/MLAs and 4 cases as regards the former MP/MLAs. In, Pathanamthitta, only 3 cases are pending for procedural compliances as regards the sitting MP/MLAs. In Kottayam, 4 cases are pending as regards the sitting MP/MLAs and 2 cases as regards the former MP/MLAs. In Alappuzha, 8 cases are pending as regards the sitting MP/MLAs. and 6 cases as regards the former MP/MLAs. In Thodupuzha, 4 cases are pending as regards the sitting MP/MLAs and 4 cases as regards the former MP/MLAs. In Ernakulam, 37 cases are pending as regards the sitting MP/MLAs, 17 cases as regards the former MP/MLAs, and 5 cases as regards the sitting and former MP/MLAs. In Thrissur, 14 cases are pending as regards the sitting MP/MLAs, 8 cases as regards the former MP/MLAs, and 1 case as regards the sitting and former MP/MLAs. In Palakkad, 18 cases are pending as regards the sitting MP/MLAs. In Kozhikode, 17 cases are pending as regards the sitting MP/MLAs and 1 cases as regards the former MP/MLAs. In Manjeri, 5 cases are pending as regards the sitting MP/MLAs and 2 cases as regards the former MP/MLAs. In Kalpetta, 7 cases are pending as regards the sitting MP/MLAs, 4 cases as regards the former MP/MLAs, and 1 case as regards the sitting and former MP/MLAs. In Thalassery, 5 cases are pending as regards the sitting MP/MLAs and 11 cases as regards the former MP/MLAs. In Kasaragod, 14 cases are pending as regards the sitting MP/MLAs and 24 cases as regards the former MP/MLAs. The details of

cases pending for procedural compliances are specifically mentioned in the list provided by the Registry.

9. Therefore, a total of 313 cases are pending in respect of both sitting and former MP/MLAs. Keeping aside the cases that have been stayed from the remaining 303 cases, 294 cases are pending for procedural compliances. The remaining 9 cases are pending where both the sitting and former MP/MLAs are involved, for procedural compliances.

10. It also appears that many cases are pending at the stage of framing charge because of non-service of summons on the accused. There are 54 cases out of 313 which are pending for more than 10 years and 127 cases for more than 5 years. The list would show that in most cases, the trial has not been proceeded on account of non appearance of the accused. The remarks in respect of the present status in several cases are that because of the non-execution of process, the appearance of the accused has not been secured in many cases.

11. In several cases, the delay is glaring. To take the example of a case, C.C.No.756 of 2019, which is pending on the file of the Court of Judicial Magistrate of the First Class – III, Thiruvananthapuram. This case arose from Crime No.26/2003 registered at the Cantonment Police Station, Thiruvananthapuram, for offences punishable under Sections 143, 147, 148 and 332 r/w. 149 of the IPC and Section 3(e) of the Prevention of Damage to Public Property (PDPP) Act, 1984. In this case, though the final report was laid on 31 March 2003, charge is not yet framed as the accused has not appeared.

12. The chart would show that out of 313 cases, 18 cases are pending for framing charges, 154 cases are pending for appearance of the accused, and 141 cases are pending due to non-service of process. In the summons trials, recording of plea are pending. Our reference to the framing of charges will include reference to both, as the case may be.

13. The service of process is an executive function and it cannot be accepted that large number of cases are pending for this reason. This aspect has been considered by the Hon'ble Supreme Court in the case of *Ashwini Kumar Upadhyay v. Union of India and Another*², wherein it was pointed out to the Hon'ble Supreme Court that due to non-execution of warrants and failure to summon the witnesses, large number of cases were pending. Therefore, certain time bound directions are necessary.

14. The learned Director General of Prosecution assured the Court that the State machinery will take all such necessary steps to ensure that the trials which are pending at the stage of framing charges (or statement of charges, as the case may be) are not held up for lack of service of process. He also submitted that necessary directions will be given to the Prosecutors appearing in these cases to take necessary urgent steps.

15. As regards the cases of which the list is already furnished by the Registrar (District Judiciary), which is available with the Directorate of Prosecution, in respect of matters which are pending at the stage of framing charges due to non appearance of the accused, we direct the Home Secretary, State of Kerala, to call for the information regarding the status of

service of process on the accused in the cases given in the list. Thereafter, necessary directions will be issued to ensure that the service of process on the accused is completed within a period of three months from today. The Home Secretary shall assign the responsibility to the Deputy Superintendent of Police in each district where the aforementioned cases are pending, to ensure compliance with the directions issued by the Home Secretary.

16. The copy of the instructions so issued by the Home Secretary shall be placed on record by the State through an affidavit of the Home Secretary by the next date of hearing. Report regarding completion of service in respect of all the cases enumerated in the list, which are pending for framing charges or statement of charges, also be placed on record by way of an affidavit.

17. As the process is completed in each cases, the concerned Judge who is hearing the cases will take a decision on the aspect of framing the charges as per law, at the earliest.
