**UPON hearing the counsel the Court made the following
O R D E R**

1. Multiple applications have been filed seeking extension of the time period prescribed under Section 3B(1) of the Unified Waqf Management, Empowerment, Efficiency and Development Act, 1995 for filing the details of waqf and the property dedicated to the waqf on the portal and database.

2. Our attention has been drawn to the proviso to sub-section 3B(1) of the said Act which provides as follows:

“Provided that the Tribunal may, on an application made to it by the mutawalli, extend such period of six months under this section for a further period not exceeding six months as it may consider appropriate, if he satisfies the Tribunal that he had sufficient cause for not filing the details of the waqf on the portal within such period.”

3. Since a remedy before the Tribunal is available for seeking extension of

time, we dispose of all the applications [I.A. No.307847/2025, I.A. No.261895/2025 & I.A. No.264695/2025 in W.P.(C) 276/2025 and I.A. No.252745/25 in WP(C) NO. 269/25 and I.A. No.255814/2025 in W.P.(C) No.284/2025) by granting liberty to the applicants to approach the Tribunal.
