Having heard the learned senior counsel for the applicants-petitioners and Shri Tushar Mehta, the learned Solicitor General appearing on behalf of the respondents.

we allow the applicants-petitioners to participate in the proceedings of the floor test to be conducted in the Special Session of the State Legislation of the Maharashtra Vidhan Sabha scheduled to be held tomorrow i.e. 30<sup>th</sup> June, 2022 at 11.00 A.M.
