2. The learned Public Prosecutor shall get instructions.

3. The petitioner was the Secretary of the Travancore Devaswom Board during the period of the alleged incident. She is arrayed as accused No.4. Annexure A1 is the FIR. The only allegation against the petitioner is that, in her capacity as Secretary to the Board, she issued an order dated 05.07.2019 reflecting the decision of the Board dated 03.07.2019, but in variance with the decision of the Board to the extent of inserting the word "hand over (Kaimarunnathinu)". According to the petitioner, the order issued by her is as per the decision taken by the Board.

4. The petitioner has produced certain medical records, which would show that she underwent a kidney

transplantation in 2013 and even at present, she is on medication. Annexure Nos. A3 and A4 would show that recent investigation revealed some abnormality to her liver. Considering all these aspects, there will be a direction to the investigating officer not to arrest the petitioner till 18.11.2025.
