Sub: Humble submission of complaint on misuse
of our Organisation name in a fake letter sent
to Honourable Justice Mr. Nirmal Kumar
about a senior counsel of High court of Madras
- praying for action regarding

We are shocked to know that the name of our
organisation, All India Lawyers Association for Justice
(AILAJ), has been misused in a fake letter sent to
Honourable Justice Mr. Nirmal Kumar about a senior
Counsel of High Court of Madras in connection with
case CrI.O.P.No.21243/2014 and CrI.R.C.No.1191/
2015, which we became aware through the order of
Honourable High of Madras in CrI.R.C.No.1191/2015
and CrI.O.P.No.21243/2014 dated 05.02.2026, and daily
news papers dated 15.02.2026.

We humbly submit that we have never sent any
such letter to the Honourable Justice Mr. Nirmal Kumar
or to any other authority, from our organisation, and our



organisation is in nowhere connected with the purported complaint. Please note that the address mentioned in that purported complaint, 'Forex Building, No.365, Thambu Chetty Street, Parrys, Chennai -600 001, is not our address and no one from our organisation is functioning from that address.

It is submitted that our Organisation's state Chapter's Head Quarter Address is as mentioned above in our letter head, and in Chennai our operational address is No. 3/254B, Jeeva Street, Vandalur, Chennai - 600048.

We humbly submit that we are not having the post of Secretary in our organisation as mentioned in that fake letter. The Tamil Nadu State Chapter of AILAJ operates under State Coordinators, of whom I am one. It is submitted that the misuse of our organisation's name is a malafide attempt to cause defame and malign our organisation and cause us disrepute, in regard to which we will file a separate complaint to the police for appropriate action.

Hence we request you to take necessary action in regard to the purported complaint which is a fake letter misusing our organisation's name, and take necessary action against the person/s behind the said fake letter.
