UPON hearing the counsel the Court made the following
 O R D E R

1. Pursuant to the reference order dated 14.11.2019, a Nine-Judge Bench was constituted to consider the questions referred therein. Objections were thereafter raised questioning the very maintainability of that reference. This issue was conclusively determined by this Court *vide* judgment and order dated 10.02.2020, whereby the Nine-Judge Bench opined that this Court can refer questions to a larger Bench even while exercising its review jurisdiction. Accordingly, the issue re: the maintainability of reference has attained finality and need not detain us at this stage.

2. Before deciding the question of maintainability, this Court also formulated the following substantive questions of law:

- (i) What is the scope and ambit of right to freedom of religion under Article 25 of the Constitution of India?
- (ii) What is the inter-play between the rights of persons under Article 25 of the Constitution of India and rights of religious denomination under Article 26 of the Constitution of India?
- (iii) Whether the rights of a religious denomination under Article 26 of the Constitution of India are subject to other provisions of Part III of the Constitution of India apart from public order, morality and health?
- (iv) What is the scope and extent of the word 'morality' under Articles 25 and 26 of the Constitution of India and whether it is meant to include Constitutional morality?
- (v) What is the scope and extent of judicial review with regard to a religious practice as referred to in Article 25 of the Constitution of India?
- (vi) What is the meaning of expression "Sections of Hindus" occurring in Article 25 (2) (b) of the Constitution of India?
- (vii) Whether a person not belonging to a religious denomination or religious group can question a practice of that religious denomination or religious group by filing a PIL?

3. In this light, and with a view to finally lay to rest the

questions of law that remain pending in these matters, we direct the parties to file their written submissions on or before 14.03.2026.

4. Ms. Shaswati Parhi, Advocate would act as a Nodal Counsel on behalf of the original writ petitioners (now contesting respondents) and other parties supporting the stand of these respondents.

5. Mr. Krishna Kumar Singh, Advocate-on-Record, would act as the Nodal Counsel on behalf of the review petitioners and also those parties supporting the stand of the review petitioners.

6. Mr. K. Parameshwar, learned Senior Counsel and Mr. Shivam Singh, learned counsel are appointed as the *amicus curiae* to assist the Court. Mr. Shivam Singh, learned counsel, shall, in this regard, prepare the written submissions keeping the stand taken by all the parties before this Court.

7. A Nine-Judge Bench to be constituted separately by Hon'ble the Chief Justice of India, through an administrative order, shall commence hearing in these matters on 07.04.2026 at 10.30 A.M.

8. The review petitioners or the parties supporting them shall be heard from 07.04.2026 to 09.04.2026. The original writ petitioners/opposing the review petitioners or those supporting them shall be heard from 14.04.2026 to 16.04.2026. The rejoinder submissions, if any, shall be heard on 21.04.2026, followed by the final and concluding submissions by the learned *amicus curiae*, which are expected to be over by 22.04.2026.

9. We lay emphasis that the parties shall adhere to the above time-schedule. Learned Nodal Counsels, in consultation with the arguing counsels of the parties, shall prepare their internal arrangement so that the oral submissions from both sides can be concluded within the stipulated time-line.

10. The additional issues that may arise for consideration in the other connected matters attached to the lead case shall be considered and formulated, if need be, before commencement of hearing in those batches.

11. The parties shall follow the Circular No.F.No.9/Judl./2024, dated 03.04.2024, issued by the Registry while making compilation of the volumes, and other miscellaneous directions.

12. All interlocutory applications seeking early hearing are disposed of accordingly.

13. All interlocutory applications seeking intervention/impleadment are disposed of with liberty to such applicants to assist the Nine-Judge Bench at the time of final hearing.

14. The Nodal Counsel(s) attached with the learned *amicus curiae* shall prepare a common compilation.
