

JUSTICE SIRI JAGAN MEMORIAL ALL KERALA LEGAL QUIZ COMPETITION

RULES & REGULATIONS

1. Lawyers with less than nine (9) years' standing at the Bar as on 28-03-2026 can participate in the competition.
2. Only Bar Associations in Kerala can send teams.
3. A team will consist of two (2) members.
4. The Kerala High Court Advocates Association can send five teams. The District Court Centres can send three teams. The Additional District Court Centres can send two teams each. Sub Court and Munsiff Court/Magistrate Court Centres can send one team each. This is subject to relaxation in appropriate cases.
5. The Controller (Academics) of this competition is Mr. Justice Pius C. Kuriakose (Former Chief Justice, High Court of Sikkim & Former Lok Ayukta, Kerala State). He has a support team who will assist him in the conduct of this competition. Mr. Justice Sunil Thomas (Former Judge, High Court of Kerala and Judicial Member, Central Administrative Tribunal) and Mr. Justice A.M. Babu (Former Judge, High Court of Kerala, Former Director, Kerala Judicial Academy & Senior Advocate, Supreme Court of India) will be the Quiz Masters.
6. Prize structure:
 - A. Rs. 25,000/- and Trophy for the Winners
 - B. Rs. 20,000/- and Trophy for the Runners Up
 - C. Rs. 15,000/- and Trophy for the Second Runners Up
 - D. Rs. 10,000/- each to the top 10 teams sponsored by eminent lawyers (most of them will be sponsored as a tribute to their senior lawyers or parents)
 - E. Special Prize of Rs. 25,000/- for the Best All-round Performer
 - F. Special Prize of Rs. 20,000/- for the Second Best All-round Performer

8. The Quiz Masters will be assisted by two Anchors who will move around the arena to facilitate the smooth flow of the competition. On their cue, the senior-most Quiz Master will ask the first question to Team No. 1 (this question will be known as a fresh question). If that team is unable to answer within 20 seconds, this question (which will be known as a Passed Over question) will be passed to Team No. 2, who will get 5 seconds to answer. If they too fail, it will go to Teams 3, 4, 5 in that order. If the question is passed over to the last team and they are also unable to answer, then the Quiz Master will give the answer. If the Quiz Master feels that any particular team should be given a fraction of the full mark, then he shall do so using his discretion.
 9. A fresh question will fetch two points and a passed over question will fetch one point.
 10. Full points will be awarded only for fully correct answers.
 11. The decision of the Quiz Master concerned will be final regarding the correctness of any answer.
 12. If an unusually large number of teams turn up for the competition, the Quiz Masters may resort to a preliminary screening test. An elimination process may also be undertaken at the end of any round to overcome time constraints.
 13. The dress code for participants is formal. Upper wear (shirt/sari/top) shall be of white colour.
 14. Entries should contain details of team members (name, address, phone number, WhatsApp number, email ID) with enrollment number and a certificate from the concerned Bar Association authorizing the team to participate on behalf of the Bar Association. The entries should be sent to "Secretary, Kollam Bar Association, Cutcherry P.O., Kollam – 691 013" by Registered Post.
 15. The last date to receive entries is 5:00 PM on 27th March 2026.
 16. The Quiz Competition will start at 10:00 AM. The contestants should report at the venue at 9:15 AM. Registration will conclude at 9:45 AM.

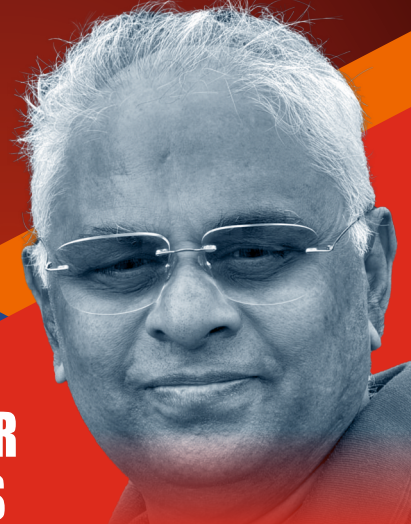
