**ORDER**

All these bail applications are filed under Section 483 of the Bharatiya Nagarik Suraksha Sanhita, 2023 (for short, BNSS) seeking regular bail.

2. The applicants are the accused Nos.3, 5, 6, 7, 8, 13, 14, 22 and 24 in Crime No.762/2026 of Museum Police Station, Thiruvananthapuram District. The offences alleged are punishable under Sections 126(2), 189(2), 191(2), 191(3), 296(b), 132, 121(1), 118(1) and 109 r/w Section 190 of the Bharatiya Nyaya Sanhita, 2023 and Section 3(1) of the Prevention of Damage to Public Property Act, 1984 (for short, the PDPP Act).

3. The prosecution case, in short, is that on 27.05.2026 at about 7.15 a.m., when the defacto complainant, who is the Assistant Director of Enforcement Directorate, Enforcement Office, Kochi along with his fellow officials conducted search in the residence of the Leader of Opposition, Kerala, bearing Door No. T.C.27/2692, situated near Bakery Junction, the applicants along with 300 identifiable persons formed themselves into an

unlawful assembly armed with deadly weapons and in prosecution of their common object, reached in front of the said house. Thereafter, at about 2.40 p.m., after completing the search formalities, the officials boarded the vehicles, which were used for their official purposes. When the vehicles entered the road, the accused persons approached the vehicles uttering obscene words and exhorted others to kill the officials, and surrounded the vehicles. Thereafter, the accused beat the official accompanying the defacto complainant using a stick, and threw stone towards the car bearing Registration No. KL-22/S-8016, causing serious injuries to the driver of the said vehicle and attempted to kill him. When the police and C.R.P.F. officials attempted to obstruct the accused persons, they also attacked the officials with sticks, stones, and bricks, causing serious injuries to them and thereby deterred the Enforcement Officials and the police party from discharging their official duties. The accused also committed mischief by damaging the vehicles, causing a total loss to the tune of Rs.3,00,000/- and thereby committed the offences.

4. I have heard Sri.P.Vijayabhanu, Sri.T.A. Shaji, Sri.K.Gopala Krishna Kurup and Sri.Sasthamangalam Ajith Kumar, the learned Senior Counsel for the applicants, Sri.S.Rajeev and Sri.Suman Chakravarthy, the learned counsel for the applicants, Sri.T. Asaf Ali, the learned Director General of Prosecution, Sri.Rasheed C. Nooranad, the learned Special Public Prosecutor, and Sri.P.Sreekumar, the learned Additional Solicitor General for India representing the defacto complainant. Perused the case diary.

5. The learned counsel for the applicants submitted that the applicants are innocent and have been falsely implicated in the present case. The counsel further submitted that no materials are on record to connect the applicants with the alleged crime; hence, they are entitled to bail. On the other hand, the learned Special Public Prosecutor submitted that the alleged incident occurred as a part of the intentional criminal acts of the applicants, and they are not entitled to bail at this stage. The learned Additional Solicitor General submitted that the allegations disclose a coordinated and organised assault on officers of a Central Investigating Agency who had lawfully

conducted search proceedings pursuant to statutory powers vested under the Prevention of Money Laundering Act, 2002. The learned Additional Solicitor General further submitted that the gravity of injuries, the continuing threat to witnesses, the incomplete investigation and the existence of a larger conspiracy are valid reasons to deny bail to the accused.

6. The applicants were remanded to judicial custody on 27.05.2026, 28.05.2026 and 29.05.2026 respectively. A perusal of the case diary reveals that the accusation against the applicants is very serious and it *prima facie* shows a premeditated criminal act on their part. As rightly argued by the learned Additional Solicitor General for India, it is a case where the E.D. officials were attacked while they were discharging their duty. However, the learned Special Public Prosecutor submits that the investigation is almost over and the recovery has been effected. The vehicle mahazars of the damaged vehicles were prepared with the assistance of the Scientific Officer. The Finger Print Tester Inspector took the finger prints of all the arrested 25 accused and sent for comparison to the Finger Print Bureau. 30 material objects were collected and sent

for forensic examination, 7 mobile phones of the accused seized were sent for cyber examination, CDR and Tower Dump were collected and analysed, wound certificate of ED officials, driver and four police personnels were collected, blood samples of accused Nos. 1 and 19 were collected and sent for DNA examination. The applicants were also given to police custody. None of the applicants have criminal antecedents involving any serious offences. No serious injuries were sustained by the victims. For these reasons, I do not find any reason to hold that the continued detention of the applicants is required for any purpose. Hence, the applicants are entitled to be released on bail.

7. There is an allegation that the accused persons have caused damage to the vehicle used by the E.D. officials. The learned Special Public Prosecutor submitted that loss has been assessed at Rs.2,20,000/-. Since the PDPP Act has also been involved, the applicants should be directed to deposit the damages caused to the vehicle as a condition for granting bail as held by this Court in **Hemachandran M.T. @ Kamlesh and Others v. Sub Inspector of Police and Another** (2011 (4)

In the result, the applications are allowed on the following conditions: -

(i) The applicants shall be released on bail on executing a bond for Rs.1,00,000/- (Rupees One lakh only) each with two solvent sureties for the like sum each to the satisfaction of the jurisdictional Magistrate/Court.

(ii) The applicants shall fully co-operate with the investigation.

(iii) The applicants shall appear before the investigating officer between 10.00 a.m and 11.00 a.m every Saturday until further orders. They shall also appear before the investigating officer as and when required.

(iv) The applicants shall not enter into the jurisdictional limits of Sub Divisional Assistant Commissioner of Police, Cantonment Police Station, Thiruvananthapuram until further orders.

(v) The applicants shall deposit Rs.10,000/- (Rupees Ten thousand only) each before the jurisdictional Magistrate Court.

(vi) The applicants shall not commit any offence of a like nature while on bail.

(vii) The applicants shall not attempt to contact any of the prosecution witnesses, directly or through any other person, or in any other way try to tamper with the evidence or influence any witnesses or other persons related to the investigation.

(viii) The applicants shall not leave the State of Kerala without the permission of the trial Court.

(ix) The application, if any, for deletion/modification of the bail conditions or cancellation of bail on the grounds of violating the bail conditions shall be filed at the jurisdictional court.
