O R D E R

Learned senior counsel for the petitioner submitted that the States of Andhra Pradesh, Arunachal Pradesh, Himachal Pradesh, Madhya Pradesh, Maharashtra, Meghalaya, Odisha, Telangana, West Bengal, Assam and the Union Territories of Dadra and Nagar Haveli, Daman and Diu, Jammu and Kashmir, Ladakh, Lakshadweep have not filed their respective status reports. Learned counsel further submitted that the remaining States have filed

their respective status reports.

Learned counsel for the respective states have sought for some more time to file their respective status reports.

Hence, four more week's time is granted to file status report subject to payment of costs of Rs.5,000/- (Rupees five thousand only) to the Supreme Court Mediation Centre within a period of two weeks from today.
