UPON hearing the counsel, the Court made the following
O R D E R

IA No. 117651/2025:

1. This application has been filed by the Delhi Urban Shelter Improvement Board (DUSIB) seeking permission to shift the residents of the eight Shelter Homes situated at Sarai Kale Khan & Anand Vihar (mentioned at page no. 13 of

the application), i.e. 1. Sarai Kale Khan Near Bus Terminal Pota Cabin No.2 (Parking Side), 2. Sarai Kale Khan in Parking, 3. Sarai Kale Khan in Parking, Double Storey at 1st Floor, 4 & 5. Sarai Kale Khan in Parking (Family), 6. Sarai Kale Khan in Parking, Double Storey at Ground Floor (Recovery Shelter), 7 Anand Vihar -I (Male), 8. Anand Vihar -II (Female) and allow them to be relocated at the following sites (mentioned in paragraph 8 of the application):

- i. Nizamuddin Basti Near Hazrat Nizamuddin Dargah;
- ii. Phool Mandi Building, Mori Gate;
- iii. 759/1 Chabi Ganj Community Centre;
- iv. Community Centre Hanuman Mandi Yamuna Bazar (First Floor);
- v. Ganda Nallah (First Floor) MCD Community Centre; and
- vi. Kashmere Gate Commercial Building, Motia Khan.

2. We direct the Director of NALSA to appoint an officer of NALSA, who shall examine the issue and submit the report on the following issues:

(I) Number of residents residing in the Shelter Homes at Sarai Kale Khan and Anand Vihar (Mentioned at page 13 of the application).

(II) Whether the alternate site as proposed by the DUSIB is sufficient enough to accommodate the number of persons residing in these Shelter Homes.

(III) The facilities available at the sites where the

residents are proposed to be relocated.

The report be submitted within two weeks from today.

3. The visit shall be conducted by the officer of the NALSA after 08.00 p.m. so that the actual number of persons sleeping/residing at the site can be verified.

4. List along with W.P. (Civil) No. 572/2003 on 15.09.2025.
