**O R D E R**

This Court as per order dated 05.12.2025 issued the following:-

*“The learned Special Government Pleader shall file an affidavit explaining the action taken pursuant to the direction issued by this Court.*

*Post on 12.12.2025.”*

2. An affidavit has been filed by the additional 4<sup>th</sup> respondent Regional Transport Officer, Ernakulam as directed by this Court on 05.12.2022. In the said affidavit it is stated that, in response to the proposal for issuing a Government notification under Section 67(1)(d) of the Motor Vehicles Act, 1988 prescribing a minimum time gap of five minutes between private stage carriages operating within city limits and 10 minutes within Grama Panchayat limits, the Government has been pleased to accord permission to the State Transport Authority/Regional Transport Authority to determine such time gaps in accordance with Rule 212(1) of the Kerala Motor Vehicles Rules, and it was further directed that the matter be placed before the appropriate Regional Transport Authority for consideration. In the affidavit the details of

It is further stated that subsequent to the interim order dated 27.08.2025 issued by this Court, the RTO discussed the matter with Chairman, RTA who is the District Collector, Ernakulam, and decided to convene a meeting on 10.09.2025 exclusively for considering of revision of time schedule of the stage carriages operating between the jurisdiction of RTA, Ernakulam. Thereupon a special meeting was convened on 10.09.2025, and after considering the submissions of the various stakeholders it was resolved in the meeting as follows:-

- i. "Not to entertain applications for fresh stage carriage permits or variation of permit conditions both in urban and panchayat areas until general schedules of timings for stage carriages other than those of the STU running on specified routes under the provisions of rule 212(i)(a) is formulated, approved and implemented with or without the assistance of Geo-Fencing and Monitory system or AI*

: 3:

*based time scheduling and management system for stage carriages followed by prompt time revision conferences in a phased manner.*

*Phase-1:*

*To begin with this authority identifies the following routes where revision of time schedules shall be formulated and given effect to on 1<sup>st</sup> November 2025.*

*(a) Aluva - FortKochi*

*(b) Kakkanad - Ernakulam and beyond to various destinations such as Edakochi, Tripunithura, Thevara etc.*

*(c) Paravoor - High Court Junction*

*(d) Vyttila - Vyttila (circular)*

*The Secretary RTA shall call upon the permit holders on the respective routes to furnish true copies of their permits and the approved time schedule, on receipt of which he shall prepare a 'route war register' afresh with a view to pursue the revision of schedules of time. This process would help identify the valid permits. The secretary shall commence the time revision conferences as may pre-fixed by him. This exercise shall be completed on or before 1<sup>st</sup> November 2025.*

- ii. To abstain from revising the time schedules of mofussil services operating on inter-regional or inter-district routes until after the STA co-ordinates the decisions of the respective RTAs under the provisions of section 68(3)(a) without which no uniform procedure can be devised and implemented in the State.*
- iii. Where voluntary installation of GPS based Geo Fencing and Monitoring system desired by the Govt. does not work, the secretary RTA shall immediately take up the matter with the Transport Commissioner to provide all facility as are necessary at the expense of the Government.*

: 4:

- iv. This authority desires that one or more accredited auctioneers be assigned with the task of auction procedure throughout the state or in the alternative, development of a software for the purpose which shall be incorporated in the Vahan portal. The Secretary shall take up this matter too with the Transport Commissioner.*
- v. This authority is of the view that the entire traffic enforcement machinery shall be overhauled in such a way that well equipped police personnel shall be deployed at various strategic points in Cochin city in place of the Traffic Wardens and Home Guards for the purpose of effective traffic management.*
- vi. The general restriction often desired by the Hon'ble High Court of Kerala that stage carriages plying in Cochin city limits shall not overtake any other stage carriage moving ahead of it, shall be strictly implemented by the traffic controllers.*
- vii. To invite detailed proposal from KSBL and other interested stake holders for examination and approval for immediate implementation of rescheduling of bus timings and management system after affording fair opportunity of hearing to the concerned bus operators of their associations. "*

In compliance with the above decision, the Regional Transport Officer, the additional 4<sup>th</sup> respondent collected the required details including valid permits and time sheets from the permit holders, after giving due publicity through newspapers. The submissions were duly scrutinized by the authority and a draft seniority list of stage carriage operators was published on the official website and notice board on 25.11.2025, inviting the objections if any, within a

period of 14 days, and after examining the objections furnished the revised timing will be allotted, and it is submitted that some reasonable and sufficient time may be granted to finalise the said process.

3. Going by the affidavit, it is seen that steps have been taken by the authorities to comply with the directions issued by this Court. This Court is of the view that the allotment of timing as sanctioned by the Government prescribing minimum time gap of five minutes between private stage carriages operating within city limits, and 10 minutes within Grama Panchayat limits should be finalised in respect of the private stage carriages entering Kochi city, the details of which is extracted above, without any delay. Accordingly, there will be a direction to the Secretary, RTA to finalise the revision of timing in respect of the vehicles of the stage carriages entering Kochi city which are detailed in tabular form as given above, as sanctioned by the Government, fixing a minimum time gap of five minutes between private stage carriages operating within city limits and 10 minutes within Grama Panchayat limits without any delay, at any rate within an outer limits of four months from the date of receipt of a copy of this order. It is further ordered that the decisions taken in the meeting held on 10.09.2025, which is extracted above, shall be strictly complied with by the authorities in the Motor Vehicles Department

as well as Police Department. It is further ordered that the prohibition on overtaking in the city limits by stage carriages shall be strictly implemented by the traffic controllers including the Officers of the Motor Vehicles Department, and the City Police headed by the City Police Commissioner, Kochi and the said authorities shall see that the same is strictly complied with, and prompt action is taken against the violators strictly in accordance with law.
