JUDGMENT

The writ petition is filed to quash Exts. P2 and P3 minutes and Ext. P4 proforma and direct the respondents to shift the proposed polling station from Madrasathul Islamiya in Kummanodu Ward (Ward No. 7) in Kizhakkambalam Panchayat to a neutral place.

2. Pursuant to the direction of this Court, the learned Standing Counsel for the respondents 1 and 2 has filed a statement, inter alia, stating that, based on the direction of the first respondent, the second respondent had submitted reports dated 10.09.2025 and 20.09.2025, and after convening a meeting of all political parties on 12.09.2025 and holding deliberations, the first respondent has issued Annexure R1(a) order, ordering the shifting of the polling station of Ward No. 7 of Kizhakkambala Grama Panchayat from the Madrasathul Islamiya to the nearby Anganawadi (No. 101) building.



In light of the above said order, I am of the view that the petitioners' grievance stands redressed.

Consequently, the writ petition is closed.
