Writ petition (civil) praying inter alia that in the circumstances stated in the affidavit filed along with the WP(C) the High Court be pleased to direct the respondent no. 3 to issue an order prohibiting all the commercial activities carried out by the 6th respondent including conduct of new year celebrations and occupying the unauthorized constructions for the same without obtaining all necessary statutory approvals and licenses as prescribed under law in the area mentioned in exhibit p3, in the interest of justice, equity and good conscience.

This petition again coming on for orders upon perusing the petition and the affidavit filed in support of WP(C) and this Court's order dated 16/12/2024 and upon hearing the arguments of M/S.V.HARISH, RAJAN

VISHNURAJ, JISSMON A KURIAKOSE & SIDHARTHAN M.T., Advocates for the petitioners, SRI.MANOJ RAMASWAMY,STANDING COUNSEL for R4 & R5, SRI.M.R.DHANIL,Advocate for R6 and of SMT.SENITTA P. JOJO, Advocate for R8, the court passed the following:

ORDER

This writ petition is submitted by the petitioners, directing the respondents 1 to 5 and 7 to take immediate steps to prevent an event proposed to be organized by the 6th respondent, in the area mentioned in Ext.P3, as part of the new year celebrations, without obtaining necessary statutory approvals and licenses prescribed under law. The main reason for submitting this writ petition is that, the area, where the event is proposed to be conducted is situated in a landslide prone area identified by the 3rd respondent, the District Disaster Management Authority. Today when the matter came up for consideration, the learned Special Government Pleader brought the attention of this Court to Annexure 1 order issued by the 3rd respondent, directing the 6th respondent not to conduct any construction activities in the said area and preventing them from organizing any function as proposed. The learned Standing Counsel for the 4th respondent Panchayat also submitted that, even though

the 6th respondent approached them seeking permission for conducting such an event, they have not granted the said permission.

2. Considering the fact that, the program is proposed to be conducted in a landslide prone area, and also taking note of the magnitude of the program, I am of the view that, Annexure 1 order issued by the 3rd respondent has to be implemented and the 6th respondent cannot be permitted to organize any program in violation of the law.

Therefore, there shall be an interim order directing the respondents 2 to 5 and 7 to ensure that the 6th respondent is not conducting any program as proposed in 'Boche 1000 Acres' at Chulika Estate in Wayanad, without obtaining necessary permissions from the respondents 3 and 4. The said respondents shall ensure that, if at all the permission is granted, the conditions imposed by the authorities concerned are strictly complied with by the 6th respondent.
