UPON hearing the counsel the Court made the following
O R D E R

Learned Amicus Curiae submitted that the States of Nagaland, Goa, Bihar, Rajasthan, Uttarakand, Orissa, Mizoram, Karnataka, Tripura, Gujarat, Uttar Pradesh and Assam, and Union Territories of Chandigarh and Andhaman & Nicobar have filed their respective affidavits.

It is also stated at the Bar that the States of Haryana, Tamilnadu, Meghalaya, Punjab, Sikkim, Andhra Pradesh, Kerala, Tamilnadu, Uttarakhand, have also filed their respective affidavits after serving a copy on the learned Amicus.

Learned Amicus submitted that some time may be granted to her to study the affidavits and make further submissions in the matter.

The States of Manipur, Jharkand, Madhya Pradesh, Himachal Pradesh, Telangana and Union Territory of Pondicherry have not complied with the order dated 03.12.2024.

Learned counsel for the aforesaid States have sought for some more time to file their affidavits.

In the circumstances, we grant three weeks' time to file their affidavits subject to payment of costs of Rs.5,000/- (Rupees five thousand only) payable to the Supreme Court Legal Services Committee within a period of two weeks from today.
