2. On 12 August 2025, the following order came to be passed:

“Heard Mr.Angels Nair, Party-in-Person, Mr.Tekchand, learned Senior Government Pleader and Mr.M.Ajay, learned Standing Counsel for Respondent No.9.

2. We have gone through the prayers drafted by the Party-in-Person. For an effective intervention, the petition has to be drafted in a precise manner. The petition contains nineteen prayers of diverse nature and it is quite clear that dealing with the petition as presented will not lead to any meaningful intervention. Since the Petitioner is appearing in person, it is advisable that he seeks assistance in drafting the petition.

3. To enable the Petitioner to carry out these amendments in the prayer, post the petition on 9 September 2025.”

Thereafter on 7 October 2025, the Petitioner-in-person was not present.

3. When the matter is taken up today, the Petitioner-in-person states that it is not possible to carry out the amendment. We are not



inclined to entertain the petition with such wide ranging prayers. Entertaining the petition with such prayers will not lead to any fruitful intervention. As and when the Petitioner files a proper petition/petitions with precise prayers, the Court may consider taking up the cause.

4. Keeping the cause open, the petition is disposed of.
