O R D E R

Leave granted.

In the case on hand, challenge is to the anticipatory bail granted to respondent - Anil Tuteja and respondent - Alok Shukla, pursuant to which it is submitted by the learned ASG that the PMLA Complaint could not be filed. We have perused the impugned

orders and the materials available on record. Suffice it is to state that it is not a fit case for anticipatory bail, but considering the said materials at this stage would be detrimental to the further proceedings and, therefore, might influence the Trial Court.

In such view of the matter, we have no hesitation in setting aside the anticipatory bail granted to respondent - Alok Shukla and are inclined to grant custody of respondent - Alok Shukla to the appellant - ED for a period of four weeks, from the date of receipt of a copy of this order, subject to the condition that he shall cooperate with the appellant - ED so as to facilitate it to complete the investigation and file the complaint. Respondent - Alok Shukla is granted one week's time to surrender.

Insofar as respondent - Anil Tuteja is

also concerned, taking note of the materials on record, we have no hesitation in setting aside the anticipatory bail granted.

In such view of the matter, we are also inclined to grant custody of respondent - Anil Tuteja to the appellant - ED for a period of four weeks, from the date of receipt of a copy of this order, subject to the condition that he shall cooperate with the appellant - ED so as to facilitate it to complete the investigation and file the complaint. Respondent - Anil Tuteja is granted one week's time to surrender.

Thereafter, respondent - Anil Tuteja and respondent - Alok Shukla shall be released, if not required in any other case, subject to the terms and conditions that may be imposed by the Trial Court.

The appeals stand disposed of
accordingly.
