Shri Gopal Sankaranarayanan, learned Senior Advocate appointed as Amicus Curiae has tendered across the Bar his suggestions for amendment to the Consumer Protection (Salary, allowances and conditions of service of President and Members of the State Commission and District Commission) Model Rules, 2020. A copy of the same has been provided to Shri K.M. Nataraj, learned ASG.

We direct the Union of India to look into the suggestions made by the learned Amicus Curiae and take an appropriate decision on the issue of amending the aforesaid Model Rules. We grant time to Union of India to do so till the end of February 2025.
