O R D E R

IA No. 124528/2025 - RECALLING THE COURTS ORDER

This application has been filed by the applicant/petitioner for recalling this Court's order dated 9th May, 2025.

We have perused the affidavit of Mr. N.Subramanian, advocate.

He has accepted his mistake when he appeared for the petitioner in SLP(Criminal) Nos.6885-6888 of 2025 as also for the accused (Mr. V.Saravanan). He has given an undertaking. Paragraph 12 of the undertaking which reads thus:

"12. Therefore, I wholeheartedly accept my mistake and unconditionally tender my unconditional apology. I have immediately withdrawn myself as the counsel for the ACM in these criminal matters concerning cash-for-job scam and also for the accused Mr. V.Saravanan. I also undertake not to appear or draw pleadings in any criminal case arising out of the criminal trials in these cash-for-job scam cases in future. I also submit that I have duly learnt the lesson and I undertake not to commit such a mistake in the future."

We accept the undertaking. As the advocate has accepted his mistake, we delete the direction issued in the order dated 9th May, 2025 for forwarding a copy of the order to the Secretary of the Bar Council of the State of Tamil Nadu for appropriate action.

By deleting only that part of the order dated 9th May, 2025, we dispose of this application. The rest of the order is maintained.

We, however, make it clear that we have rejected the prayer (a) made in the application by the applicant/petitioner.
