In W.P.(C) No. 1083/2019, application for condonation of delay in filing the application for setting aside abatement, and applications for setting aside abatement and for the substitution of the legal representatives of the deceased petitioner No. 2 are allowed, subject to all just exceptions.

Amended memo of parties will be filed within two weeks.

The respondent, Union of India, shall file an affidavit, indicating and stating the total number of First Information Reports as well as chargesheets filed under Sections 3 and 4 of the Muslim Women (Protection of Rights on Marriage) Act, 2019.

Parties will also file written submissions, not exceeding three pages, along with judgments relied upon in support of their contentions and submissions.
