**UPON hearing the counsel the Court made the following
O R D E R**

- 1 A status report has been submitted on behalf of NOIDA in compliance with the order of this Court dated 28 February 2022. An IA (IA No 72480 of 2022) has been filed by the Interim Resolution Professional.
- 2 The status report submitted by NOIDA, *inter alia*, indicates that Edifice Engineering carried out a test blast, upon which it has redesigned the final building blast designs. It has been stated that it may not be possible to demolish the entire structure finally by 22 May 2022 and time would be required until August 2022.
- 3 It has been stated that the Director, CBRI, by a communication dated 11 May 2022, has also indicated that the work of final demolition may be carried out by 28 August 2022.

- 4 In view of the expert opinion, time for completing the work of demolition is extended until 28 August 2022. A status report shall be filed by NOIDA after convening a meeting of all stake holders on the steps which are being taken between the date of this order and a week prior to the next date of listing.
- 5 List the applications on 29 July 2022.
