O R D E R

Assam Tea Corporation Ltd. (ATCL)

Learned senior counsel appearing for the State of Assam on instructions states that the amount of Rs.70 crores (approximately)

will be paid by two yearly installments.

Time of four weeks' is granted to the State to file an affidavit in that behalf.

For considering the affidavit of State of Assam, list on 24th January, 2025.

Mahavir Plantations Pvt. Ltd:

The case of Mahavir Plantations Pvt. Ltd. will also be considered on 24th January, 2025.

Peermade Plantations Pvt. Ltd:

As far as the Peermade Plantations Pvt. Ltd. is concerned, we grant time till 15th February, 2025 to deposit the balance amount of Rs.54,21,848/- (Rupees Fifty Four Lakhs Twenty One Thousand Eight Hundred and Forty Eight Only) subject to condition of depositing Rs.25,00,000/- (Rupees Twenty Five Lakhs) by the end of January, 2025.
