Upon hearing the counsel the Court made the following
O R D E R

1. The present Writ Petition is filed for the following
reliefs:

"a. Issue a writ of PROHIBITION against the
State of Madhya Pradesh and the Madhya
Pradesh Police from taking any coercive
action against the Petitioners or their
family;

b. Issue a writ of MANDAMUS directing the
State of NCT of Delhi and the Delhi Police
to protect the Petitioners during their

stay in Delhi;

c. Issue a writ of MANDAMUS directing the State of Madhya Pradesh to initiate action against SP Asit Yadav and his subordinates of the Madhya Pradesh Police at Bhind, who were involved in acts of violence against the Petitioners;

d. Pass such other writs or orders as this Hon'ble Court may deem fit and proper in the interest of justice."

2. Issue notice confined to respondent nos.1 & 2, returnable on 09.06.2025.

3. Dasti service, in addition, is permitted. Let steps for service be taken before next date of listing.

4. Learned counsel for the petitioners is permitted to serve the learned standing counsel for respondent nos.1 & 2/States.

5. In the notice itself let it be mentioned that the respondents are required to file the counter affidavit before the next date of listing.
