O R D E R

I.A. No.200287/2025

1. The prayer in this application amounts to advising the SIT to

conduct its investigation in a specific direction. It may not be advisable for this Court to express any opinion at this stage. Sufficient directions to safeguard the liberty of the beneficiaries of higher compensation have already been issued. No additional directions are necessary at this stage.

2. Interlocutory Application is, accordingly, disposed of.

I.A. No.262363/2025

3. The averments in this application amount to the explanation of his actions, if the petitioner seeks to tender his defence. All that we observe is that these facts may be placed before the SIT for their consideration. No directions from this Court are required.

4. Interlocutory Application is, accordingly, disposed of.

Main matters

5. The status report dated 26.10.2025 and the Supplementary Status Report issued by the SIT are taken on record.

6. We appreciate the steps taken so far. We hope that the SIT will be able to complete the inquiry at the earliest. However, in view of the prayer made for extension of time, we grant the SIT an additional period of two months to conclude the inquiry.

7. A fresh status report, in this regard, be filed.

8. Liberty is granted to NOIDA to place on record the additional documents.

9. Post the matters on 21.01.2026.
