O R D E R

1. No one has entered appearance on behalf of the National Green

Tribunal Bar Association.

2. The Registrar General of the National Green Tribunal is directed to hold elections of the NGT Bar Association, for which, if need be, an Election Committee and a Returning Officer, from amongst the senior members of the Bar, who are not contesting the elections, may be constituted/appointed. The elections shall be completed, in all circumstances, by 31.03.2025. A compliance affidavit in this regard be filed by the Registrar General of the National Green Tribunal.

3. Learned counsel for the Bar Council of India as well as other counsel, representing various Bar Associations, have informed that the elections for the Delhi High Court Bar Association and the various District Bar Associations in Delhi are now scheduled to be held on 21.03.2025.

4. Let the elections be held on the fixed date without any further deferment.
