Issue notice, returnable in the week commencing 19.05.2025.

Notice is accepted by Mr. E.C. Agrawala, learned counsel, and Mr. Aman Dixit, learned counsel, who are present in Court on caveat/advance notice on behalf of respondent nos. 1 and 3, respectively. Hence, notice need not be served on these respondents.
