UPON hearing the counsel the Court made the following
O R D E R

IA No.305931/2025

1. After hearing learned counsel for the Bar Council of Punjab & Haryana, paragraph 12(III) of the order dated 18.11.2025 is modified to the extent that the entire election programme for the State Bar Council of Punjab & Haryana, including the counting of votes and subsequent declaration of results, shall, in any case, be concluded by 30.04.2026, instead of 15.03.2026. The elections may continue as per the schedule already notified on 10.11.2025 (i.e., before order dated 18.11.2025) was passed, subject to the above-modified timeline and the other directions of this Court in order dated 18.11.2025.
2. The Interlocutory Application is, accordingly, disposed of.
