O R D E R

Shri Prashant Kumar Shrivastava and Shri H.P.Meena,
Additional Superintendents of Police, are present before

this Court.

The presence of the said officers before this Court is dispensed with for the present during the future hearings of this case.

Learned Additional Solicitor General appearing for the respondent(s)-CBI and learned Standing Counsel appearing for the respondent(s)-State submitted that the two police officers namely Mr.Sanjeev Singh Mavai and Mr.Uttam Singh Kushwah have been arrested from Shivpuri on 05.10.2025 and Indore on 27.09.2025 respectively and they are presently lodged at Indore Jail.

However, we find that the arrest has been made pursuant to the stringent observations made by this Court.

The fact remains that there has been non-compliance of the direction(s) issued by this Court *vide* order dated 15.05.2025 and it is only pursuant to the filing of this Contempt Petition and the observations made by this Court that the arrest of the aforesaid two officers has taken place.

In the circumstances, we direct that the concerned respondent(s) to file an explanation as to why there has been a lapse in complying with the order of this Court dated 15.05.2025 and that the arrest of the said officers have been made only on 05.10.2025 and 27.09.2025.

For the purpose of filing the said explanation, we adjourn the matter to 06.11.2025.

The respondent(s)-State may also state the further

departmental action that has been taken as against the aforesaid two officers, who have now been arrested, by the next date of hearing.

Learned Additional Solicitor General appearing for the respondent(s)-CBI and learned counsel appearing for the respondent(s)-State also submitted that the affidavit(s) on behalf of the concerned respondent(s) have been filed.
