UPON hearing the counsel, the Court made the following
O R D E R

IA No. 198522 of 2025:

1. This is an application seeking interim bail.
2. It is the contention of the applicants/petitioners that in order to deprive the petitioners of liberty, once the petitioners are granted bail in one matter, another FIR is registered so as to ensure that the petitioners remain languishing in jail.
3. We had issued notice in the writ petition on 14.11.2024.
4. On the last date, the petitioners had expressed the apprehension that once they are released, another FIR may be registered against them, and they may be consequently arrested. Today, this application has been filed stating that the fear and apprehension so expressed has turned out to be correct.
5. We have heard Mr. Siddhartha Dave, learned senior counsel for the petitioners and Mr. K.M.

Nataraj, learned Additional Solicitor General for the respondents.

6. The application is allowed.

7. The petitioners are directed to be released on bail in connection with FIR No. 141 of 2025, dated 13.08.2025, registered at P.S. Mirzapur, District Saharanpur, Uttar Pradesh, to the satisfaction of the trial Court.

8. It is further added that the petitioners shall not be arrested by the respondents in any of the FIR(s) which will be lodged hereinafter, without the leave of this Court.
