UPON hearing the counsel the Court made the following

O R D E R

1. In the counter affidavit filed on behalf of the State of Uttar Pradesh, it is averred that the Mukhtar Ansari died on 28.03.2024, while he was in custody. Thereafter, postmortem was conducted by a panel of Doctors, who have opined that the deceased died by Heart Attack i.e., the natural cause.

2. Mr. Kapil Sibal, learned senior counsel representing the petitioner (the son of the deceased) submits that since the magisterial inquiry has been conducted and a report is furnished, those should be made available along with the medical report to the petitioner.

3. Responding to the above, Mr. K.M. Natraj, learned ASG submits that the requisite medical report and the magisterial inquiry report on the death of the deceased, will be furnished within three weeks.

4. If any response is proposed to be filed by the petitioner, the same be done within three weeks thereafter.
