We direct the petitioner to implead Shri Karan Singh Wazir (son of the deceased) as party respondent no.5. The amended cause title shall be filed within a period of one week from today.

Issue notice, returnable on 28th January, 2025.

The learned Advocate-on-Record appearing for respondent no.1 and respondent no.5 take notice.

In the meanwhile, the trial against the petitioner will not proceed and the direction issued in paragraph 59 of the impugned order dated 4th November, 2024 will remain stayed. We make it clear that we are not staying the proceedings of the pending revision application before the High Court and the High Court is free to proceed in accordance with law.
