UPON hearing the counsel the Court made the following
 O R D E R

1. Pursuant to this Court's direction vide judgment dated 28.05.2025, the Status Report filed by the DDA is taken on record. The Forest Department shall also file a Status Report with respect to the suitability of the 185 acres of land allocated for compensatory afforestation/plantation. It shall also briefly explain the species of the plants resolved to be planted and the timeline within which the plantation will be completed.
2. In respect of the other directions also, the Chief Secretary of the GNCTD and the Vice-Chairman of the DDA are directed to file their respective Status Reports before the next date of hearing.

3. It goes without saying that the petitioner will also be at liberty to file an affidavit highlighting which part of the directions has been complied with, partially or fully, and most importantly the directions which are yet to be implemented.
4. Let such an affidavit be filed within four weeks.
5. The Forest Department shall also place on record a sketch plan depicting the location of the 185 acres of land within the NCT of Delhi along with the proposal for plantation.
