1. Heard learned counsel appearing for the parties.
2. Having considered the facts and circumstances of this matter and the submissions advanced by the learned senior counsel for the petitioner, the transfer petition is allowed.
3. Accordingly, the Criminal Case bearing No. 3869/2019 M.P. SCPPS 09/2022 pending before the Court of Additional Sessions Judge, Gwalior, Madhya Pradesh, is transferred to the Presiding Judge, Tis Hazari at New Delhi, who may hear the case himself or assign it to a court of competent jurisdiction.
4. Records of the case should immediately be transferred to the transferee court.

5. The trial to be concluded by the Transferee Court within a period of six months.

6. It goes without saying that both the sides; the prosecution and the defence, will cooperate in the conclusion of the trial within the time stipulated above.
