UPON hearing the counsel the Court made the following
O R D E R

1. Delay condoned.
2. This petition pertains to grant of furlough/parole in the year 2023 and we are in the year 2025. Apart from that Mr. Mukul Rohatgi, learned senior counsel for the respondent(s) has raised a question with regard to even the maintainability of the Public

Interest Litigation in respect of the individual matters.

3. In that view of the matter, we are not inclined to consider the present petition.

4. It is further to be noted that the High Court in paragraph 6 of the order itself observed that in case any application is made by Respondent no.9 before it for temporary release, the same shall be considered strictly in accordance with the provisions of the Haryana Good Conduct Prisoners (Temporary Release) Act, 2022, without the competent authority indulging in arbitrariness, favoritism or discrimination.

5. The special leave petition is, accordingly, disposed of.

6. Pending application(s), if any, shall stand disposed of.
