O R D E R

Re-list in the week commencing 21.04.2025.

Interim order will continue to operate till the next date of hearing and will equally apply to the cases now mentioned in the amended writ petition.

We also deem it appropriate to direct that no further cases will be registered and proceeded without the permission of this Court.
