O R D E R

1. Issue notice.
2. Dasti, in addition is permitted.
3. The State prays for cancellation of Bail. The High Court has delivered a lengthy judgment granting bail to some of the accused persons. The apprehension expressed today by the State is that the other co-accused should not be permitted to take benefit of the findings recorded by the High Court in the impugned order, which is now a subject matter of challenge before us.
4. Since the State is praying for cancellation of bail, it would not be proper for us to stay the operation of this impugned order otherwise it would tantamount to cancelling the bail. However with a view to protect the interest of the prosecution. We clarify that if any other co-accused prays for bail, the Court concerned shall not place reliance on the impugned order before us. If any bail application is filed in future by any other co-accused it shall be decided on its own merits.
