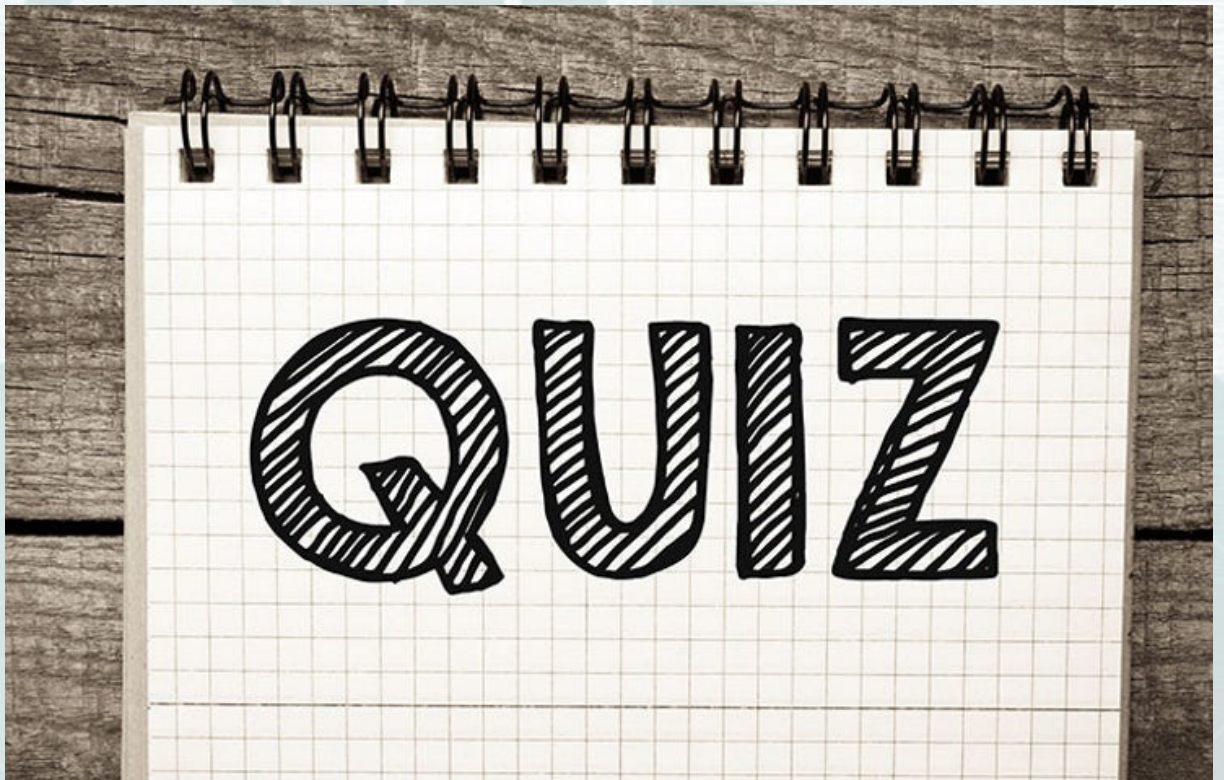
Counsels' Cottage
