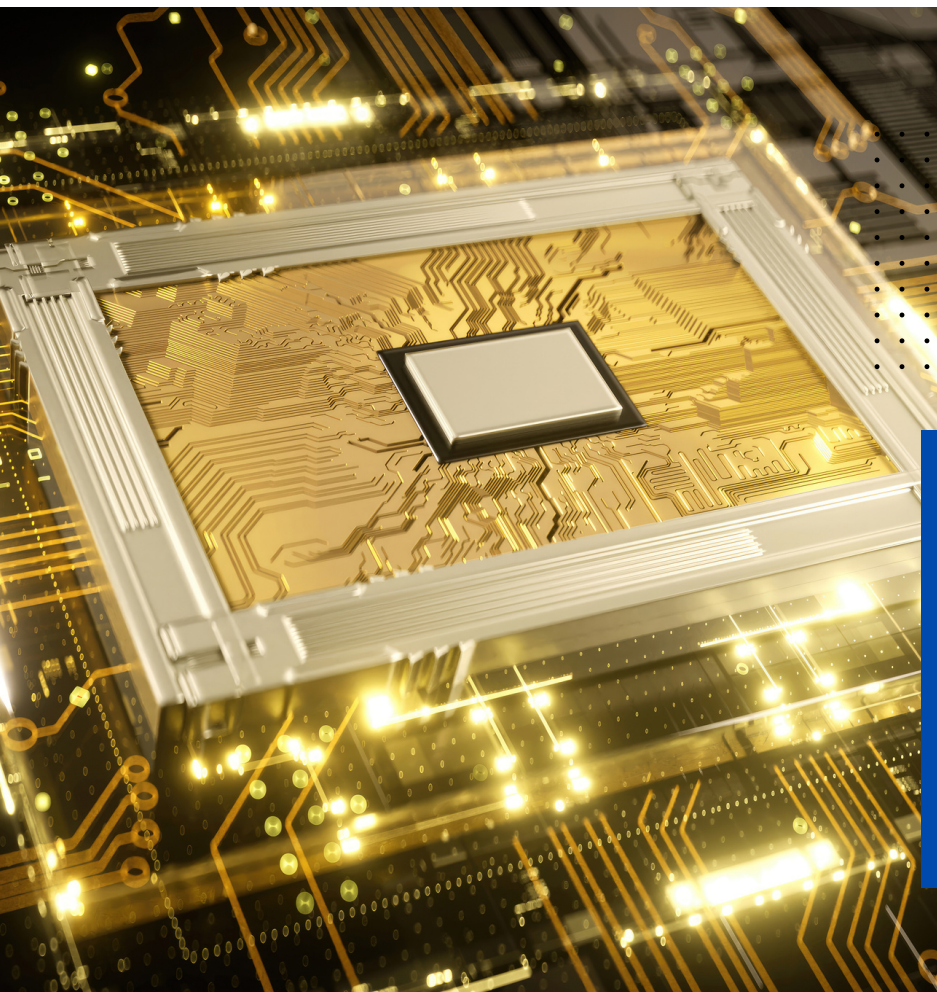
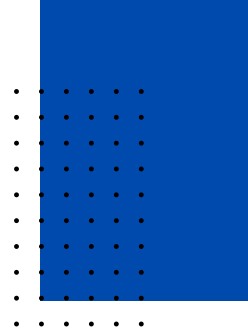

CALL FOR BLOGS

CIIPR accepts submissions on a *rolling basis*. The subject of the submission should deal with any contemporary and pertinent development related to Intellectual Property Rights. Submissions may be in the form of articles, opinions, case comments, and short notes. Further, submissions analysing or critiquing already existing academic research on a topic or issue are also welcome. Purely descriptive pieces are discouraged. Manuscripts will be evaluated majorly based on originality, novelty, structure, analysis and argumentation. The Editorial Board reserves the right to reject the manuscript if the manuscript does not fulfil these criteria.

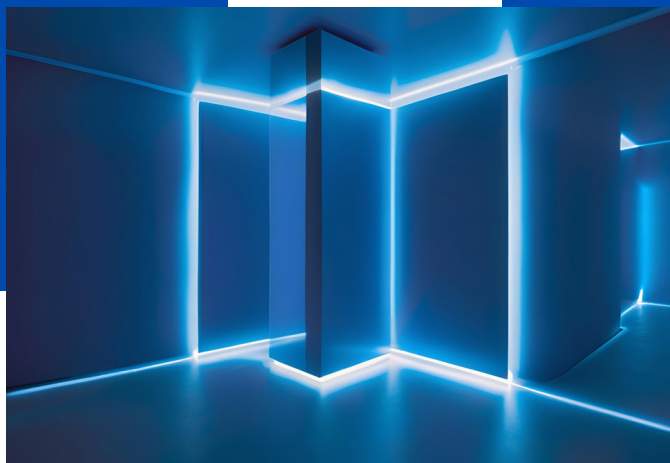
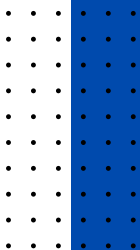
SUBMISSION GUIDELINES

- Co-authorship of a maximum of two authors is allowed.
- All submissions must be original and unpublished. Plagiarism of any kind will lead to disqualification of submission. The author(s) will bear sole responsibility for the accuracy of facts, opinions, or views stated in the submitted manuscript.
- Submissions can be up to 1500 words, exclusive of endnotes. The stipulated word limit is flexible subject to Editor's discretion in exceptional cases.
- Authors shall refrain from referring to themselves in the first person in the manuscript. Further, while referring to case laws, authors are encouraged to use the names of the parties instead of referring them as "petitioners" , "appellants" , "respondents" , etc.
- The Submission will be accepted via google forms.



FORMATTING AND CITATIONS

- Submissions shall be typewritten in Times New Roman, font size 12 with line spacing of 1.5 with justified alignment.
- All references must be in the form of hyperlinks, linked to keywords or phrases in the manuscript. If no hyperlink is available, endnotes should be used for reference. Speaking endnotes or footnotes are strictly prohibited. All relevant sources which are available as open-source documents such as judgments, laws, reports, articles and other sources shall be provided as hyperlinks within the main text of the document itself. However, where a source is not available as an open-source document, the same shall be cited by providing an endnote instead of a footnote.
- The latest edition of the Oxford University Standard for Citation of Legal Authorities (OSCOLA) shall be followed for citations, and endnotes shall be typewritten in Times New Roman, font size 10, single line spacing, and justified alignment.
- The author shall maintain anonymity throughout the article and shall not disclose his/her name, institution's name or any other information that identifies the author in the file containing the article.
- Any form of plagiarism is strictly prohibited and the submission shall be original, unpublished, and an outcome of the author's own efforts. Manuscripts with high AI similarity level shall be summarily rejected. Author(s) shall divest the copyright of the manuscript to IPR Law Review Centre for Innovation and Intellectual Property Rights, Rajiv Gandhi National University of Law, Punjab, once the manuscript has been selected for publication. However, all moral rights shall remain with the author(s). Author(s) shall refrain from submitting the manuscript elsewhere during the pendency of the review process. If the theme of the manuscript is contemporaneous to the time of submission and a delayed publication would render the research irrelevant, the author(s) may request an expedited review of their submission.



SUBMISSION PROCEDURE



The author(s) shall submit the manuscript along with the duly signed Certificate of Originality and Copyright (**in the attached format**) via Google Form **here**.



The Editorial Team strives to communicate its decision regarding publication of the blog at the earliest. Ordinarily, the author(s) shall be apprised of the decision of the Editorial Team within a fortnight from the date of submission. The author(s) shall, therefore, refrain from sending any follow-up emails to the Editorial Board before this period. All queries shall be sent to the Editorial team at **ciipr@rgnul.ac.in**

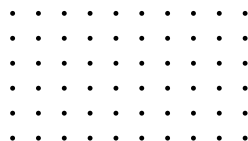
ADDITIONAL MATERIAL

All submissions must be accompanied by:

- An author bio (1-2 lines), and social media handles
- A short summary of the submission (around 80 words), along with 4-5 keywords

WITHDRAWAL POLICY

- If the author(s) wishes to withdraw their piece from consideration, they shall send an email with the subject line, 'Withdrawal of Manuscript ' to ciiprrgnul2023@rgnul.ac.in. The Editorial Board will take the final decision regarding this matter.
- In the event that a manuscript submitted to IPR Law Review has been submitted and accepted by any other journal or blog, the author must withdraw their submission from IPR Law Review. If the Blog accepts the manuscript first, the author must withdraw it for consideration from all other journals or blogs. Failure to do so will lead to the removal of the piece from consideration for publication in IPR Law Review.
