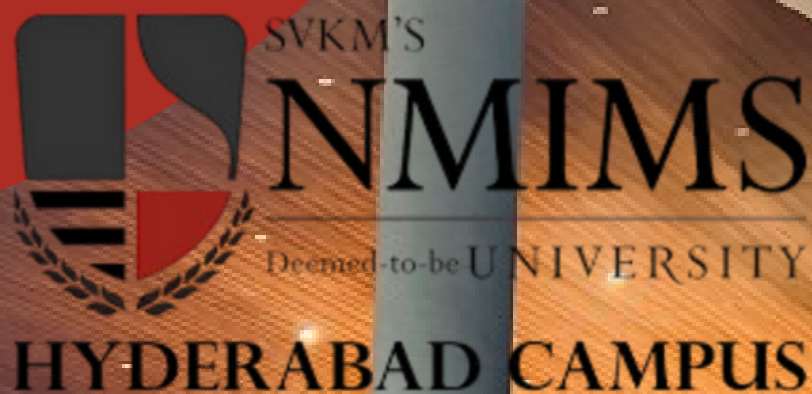

# 3rd NMIMS HYDERABAD MOOT COURT COMPETITION, 2025

# MOOT PROPOSITION

1. Did Akhil Kumar conduct a prior verification of the encumbrances and reach an agreement with the mortgagee regarding the mortgage on the property in question?

**Clarification:** No, he has not obtained EC.

2. Has Akhil Kumar made any improvements to the third floor?

**Clarification:** No, due to his financial conditions.

3. As per the terms of the initial agreement between Akhil Kumar and Surya Prakash, when is the execution scheduled to take place?

**Clarification:** Please refer to the first paragraph of the Moot Proposition. Teams are free to interpret it as they see fit. However, the initial agreement of sale does not specify a deadline for its execution.

4. What is the role of Anil Kumar in the given case (how is he related to Surya Prakash)?

**Clarification:** It is a typing mistake. Anil Kumar is Akhil Kumar. There are only three Characters namely, Surya Prakash, Akhil Kumar and Antony.

5. Are the Substantial Questions of Law in framed by the Court the issues?

**Clarification:** The issues are the Substantial Questions of law mentioned in Page 6 of the Moot Proposition. There are 5 Issues, and participants are free to club the issues but all issues must be dealt with.

6. Evidence Act referred in the Moot Proposition, is the new act or the old act?

**Clarification:** It is the old Evidence Act as the suit was filed before BSA coming into force.

# REGISTRATION

1. When is the Provisional Registration open until?

**Clarification:** The last date to provisionally register is **8th March, 2025 (11:59 PM)** and the last date for Final Registration is **9th March, 2025 (11:59 PM)**. Participants can be allowed an additional time extension after **9th March, 2025 (11:59 PM)** to register upon a mail from their Moot Court Committee or Faculty In-Charge/Mentor to the organising committee.

2. Where can we find the link for Final Registration?

**Clarification:** Upon confirmation of the teams provisional registration, they would receive a mail with the subject “Confirmation of Provisional Registration | 3rd NMIMS Hyderabad Moot Court Competition, 2025”. This mail will have the link to the Final Registration attached.

3. Is the Authorization a proof from the teams institution or from the organising committee?

**Clarification:** In the Final Registration form, the Authorization letter required is from the participants side serving as a No Objection letter from their institution regarding the participation of the teams.

4. If there is more than 1 team from the same institution is the overall procedure to be done once only?

**Clarification:** For each team doing their Final Registration, they would be required to fill their details separately. If there are 2 teams from the same institution, the authorization letter for the teams would have to be separate, applicable of the same with payment.

5. What does Authorization Letter include?

**Clarification:** The Authorization Letter from the participants institution shall serve as a No Objection Letter from the institution, containing the participants details.

6. Is the registration fee refundable if a team doesn't qualify Memorial Selection?

**Clarification:** No.
