This is a fresh application for placing facts on record on behalf of applicant/accused Asif Iqbal Tanha.

Ld. Counsel for the accused has moved an application pressing that after the release, accused Asif Iqbal Tanha is going to ordinarily reside at SIO of India, D-300, Abul Fazal Enclave, Jamia Nagar, New Delhi-110025. The accused does not have the passport and even the phone number has been provided by the applicant to the Officer Special Cell.

Ld. Special Public Prosecutor has submitted that permanent address of the accused of Jharkhand has been verified and so has the status of both the sureties Inam Ur Rehman and Najmuddin been verified.

Ld. Special Public Prosecutor has taken the objection that address mentioned by the accused in the bail bond at D-122, Abul Fazal Enclave, Thokar No.3, Shaheen Bagh, Delhi is incorrect as the accused Asif Iqbal Tanha has never resided at the said address.

Ld. Counsel for the accused has clarified that accused used to reside at the address of D-22, Abul Fazal Enclave, Thokar No.3, Shaheen Bagh, Delhi prior to his arrest and due to his arrest, the said tenancy has expired.

The address has also been inquired from the accused Asif Iqbal Tanha, who is also available in WebEx proceedings.

As per report of Ahlmad, the original FDR bearing no. 787442 dated 15.06.2021 for Rs.50,000/- of Indian Bank, Chennai-600014 by surety Inam Ur Rehman and the National (Small) Saving Scheme No. 020013145646 of Rs. 50,000/- by surety Najmuddin have been furnished, same are taken on record.

In these circumstances, bail bonds of accused Asif Iqbal Tanha are accepted. However, IO will file the fresh verification report of the address of D-22, Abul Fazal Enclave, Thokar No.3, Shaheen Bagh, Delhi, the new address furnished by the accused i.e. SIO of India, D-300, Abul Fazal Enclave, Jamia Nagar, New Delhi-110025 on the regular date of hearing i.e. 15.07.2021.
