Counsel for the plaintiff prays for extension of time to file affidavit in reply in connection with GA/1/2024 and affidavit in opposition in connection with GA/2/2024.

Counsel for the defendants have drawn the attention of this Court to the order dated 30th January, 2025 wherein this Court has given last chance to the plaintiff to file affidavit in opposition and affidavit in reply within a period of two weeks.

Counsel for the plaintiff submits that due to some difficulties, affidavit in reply and affidavit in opposition could not be prepared and he prays for extension of time.

As a matter of special chance, time to file affidavit in opposition and affidavit in reply is extended for a further period of two weeks from date.

Counsel for the defendants pray for time to file affidavit in opposition in connection with GA/3/2025.

Let affidavit in opposition be filed within three weeks. Affidavit in reply, if any, thereto be filed within a week thereafter.

Counsel for the plaintiff submits that interim order granted earlier, which was modified by the Hon'ble Appellate Court, may be extended.

In view of the submission made by the Counsel for the plaintiff, the interim order granted earlier which was modified by the Appellate Court is extended till 10th April, 2025 or until further orders, whichever is earlier.
