 O R D E R

3. We have heard the learned Senior Counsels appearing for the parties at length on the application bearing (IA No. 157897/2025).

4. We have been informed that officially, today is the last day of the Kanwar Yatra and in any case, it is likely to come to an end in the near future. Therefore, at this stage, we deem it appropriate to direct that all the concerned hotel owners, shall comply only with the mandate of displaying the license and the Registration Certificate outside their hotels, as statutorily required.

5. Necessary compliance of this order must be made within a period of two weeks from the date of receipt of a copy of this Order.

6. We make it clear that we have not gone into the merit of the other issues argued.

7. Accordingly, the application (IA No. 157897/2025) stands disposed of.
