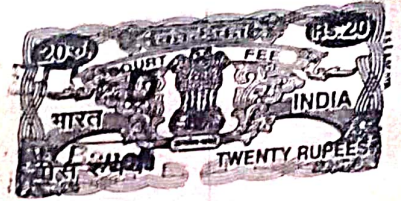

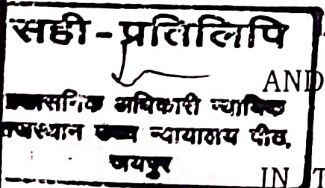

1. Learned counsel for the petitioner submits that petitioner was appointed on the post of Peon-Multi Tasking Staff (for short, "the MTS") vide order dated 26.08.2013. Counsel submits that as per the duty chart assigned to such Peon (MTS), the respondent is not supposed to direct the petitioner to clean the ladies toilet. Counsel submits that in contravention to the task assigned to such Peon (MTS) vide Annx.II, the order impugned has been passed. Counsel submits that when the petitioner refused to do the

cleaning work of the ladies toilets, the respondent has initiated Disciplinary Proceedings against her in violation of her right to life, granted under Article 21 of the Constitution of India.

2. Issue notice of the writ petition as well as to the stay application. Rule is made returnable by 12.03.2025.

3. Notices be given 'dasti'.

4. Till next date, the respondent is restrained to take any coercive action against the petitioner.
